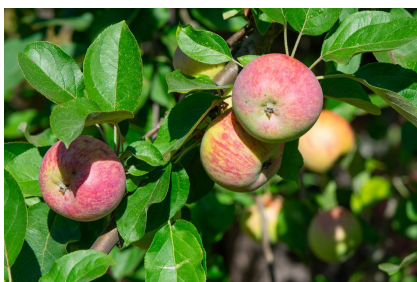
Welcoming Our Newest Employee
