National Native American Heritage Month

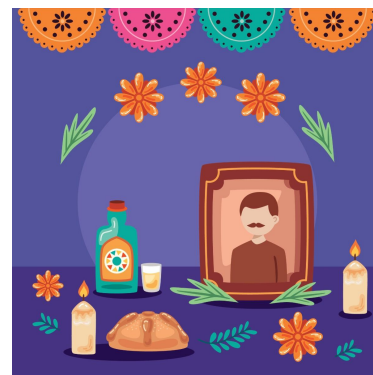
This Native American Heritage Month, we honor and celebrate the rich culture, traditions, and contributions of Indigenous peoples.
